TERMS & CONDITIONS: MEAT WORLD MUSIC FESTIVAL (ADDENDUM A) SPRINGS FRESH PRODUCE MARKET

- 1. No stall booking will be made or confirm without immediate payment
- 2. If the Organisers cannot allow my stall to be booked due to any reason, the amount that was paid in will be refunded to the Stall Owner
- 3. No booking is guaranteed until you receive a contract from us and accordingly signed by both parties.
- Only a limited amount of electricity stalls can and will be allowed. No electricity stall is guaranteed until you receive a contract. In the case of load shedding, NO electricity will be provided.
- I will be honest about my electricity usage as regular tests will be done and you will be charged accordingly
- 6. The Festival is subject to any Covid-19 Regulations
- 7. I will adhere to all safety requirements
- 8. The Meat World Music Festival is an all weather Festival. No monies will be refunded.
- 9. I will provide the names and contact details of all persons that will be manning my stall (s)
- 10. I will adhere to all instructions from the Organiser. Any contravention of the rules will lead to immediate suspension without any refunds.
- 11. I will be on time. Late comers will not be allowed without any refund
- 12. All vendors are required to trade during the MEAT WORLD MUSIC FESTIVAL's trading times:
 - a. Saturday, 26 April 2025 from 08:00 to 18:00
 - b. Traders are not permitted to leave before the end of the trading period.
- 13. All vendors can start setting up by 05:30 and must be fully set up by 08:00 on Saturday,26 April 2025. NO EXCEPTIONS.
- 14. No late arrivals will be permitted to enter the venue.
- 15. No re-entry will be accepted if vendor chooses to leave early. NO EXCEPTIONS.
- 16. You must bring your contract with you when you check in the day of the event. You will receive more information via email outlining set up prior to the event.
- 17. Bring your own tables, chairs, gazebos etc.
- 18. The Vendor is not allowed to damage any area or property. If the Vendor damage the area, he/she will be accountable for the fixing of the area and will have to pay the Organiser directly. Vendors are NOT allowed to put in any nails, pens or other material in the tar and/or paving, cement, bricks etc.

- Every Vendor will receive 2 (Two) Tickets (wristbands) per stall.
 PLEASE NOTE: The tickets/wristbands are NOT transferrable.
- 20. Your stall number will be provided one week in advance of the market.
- 21. Your vehicle needs to be removed from the exhibition area, after offloading to the provided parking area for stallholders, but before 07:15 on the day.
- 22. If you cancel your stall, the organizing committee will keep your fees as compensation.
- 23. No spaces will be available to rent on the days of the event. Individuals can team up to rent a space, as long as the items remain in the space. Subletting, loaning, renting, or selling of your booth space to someone else is strictly prohibited. All rights to the booth space belong to Lefra Productions (Pty.) Ltd. Booths can be reassigned, when necessary, for the good of the festival.
- 24. On the day of the festival, if it rains, snow or shine, all activities will continue and there are no refunds.
- 25. Vendors that don't keep to the rules of the market, may be asked by the Organisers to leave the premises immediately.
- 26. Items that may not be sold: No firearms, tobacco, combustibles, alcohol, knives, swords, or weapons of any kind. No fuel-based items, such as vehicles, lawn mowers, etc., may be sold inside. Also no provocative or suggestive items. No food and beverages allowed unless contracted to do so.
- 27. The Vendor will only be allowed to sell the items on the application. If the Vendor sell any other items that was not approved, the Organiser will request the Vendor to leave immediately without any refunding of any money paid in.
- 28. The Vendor will accept the placement of his/her stall by the Organiser.
- 29. With regard to electricity stalls: The ORGANISER will only supply a basic 16 Amp Plug Connection. Any extra electricity requirements will be for the VENDOR's account and will be quoted by the Organiser's Electrician. The VENDOR will supply his/her own electricity extension from the VENDOR's stall to the electricity supply point. Only equipment as was approved by the ORGANISER or his representative will be allowed in the stall. Inspections will be carried out during the Festival. VENDORS of all electricity stalls, MUST supply the ORGANISER with a COA Certificate.
- 30. In the case of load shedding, the Organizers will not be able to supply electricity.
- 31. The vendor will adhere and take responsibility of all Health and Safety Legislation. Vendors are required to keep a fire extinguisher in their stalls at all times.
- 32. No electrical heaters are allowed in stalls.
- 33. Vendors are advised to bring a battery-operated light for the evenings and nights.
- 34. The MEAT WORLD MUSIC FESTIVAL is organized subject to Covid-19 Rules and Regulations. Should new Covid Regulations be promulgated and the Festival cannot

carry on, no refunds will be given to Vendors. The Festival will however be postponed to a later date with the same terms and conditions for stalls and vendors.

- 35. Vendors are allowed to leave their stalls and trailers overnight. Security will be provided, but vendors acknowledge that they leave their stalls and merchandise at their own risk.
- 36. This agreement shall not constitute or be considered a partnership, employeremployee relationship, joint venture or agency between Lefra Productions (Pty.) Ltd., SPRINGS FRESH PRODUCE MARKET, Meat World and the vendor.
- 37. The vendor will indemnify, defend, and hold harmless Lefra Productions (Pty.) Ltd., SPRINGS FRESH PRODUCE MARKET and Meat World, their parent companies and affiliates and their respective officers, directors, employees and representatives, and the successors and assigns of any of them, from and against, and reimburse them for, all claims, damages, costs and expenses, including, without limitation, interest, penalties, court costs and reasonable attorneys' fees and expenses, arising out of or resulting from (a) any breach of any representation, warranty, covenant, obligation or other agreement contained in this Agreement; (b) out of any failure of the vendor to comply with any applicable laws, statutes, ordinances or regulations; (c) any act or omission or negligence of Exhibitor or its employees, agents, contractors or invitees; (d) any claim for personal injury or property damage or otherwise brought on behalf of any third party person, firm or corporation against Lefra Productions (Pty.) Ltd. or SPRINGS FRESH PRODUCE MARKET or MEAT WORLD as a result of or in connection with vendor's stall which claim does not result from the active negligence of Lefra Productions (Pty.) Ltd. or SPRINGS FRESH PRODUCE MARKET or MEAT WORLD (e) any announcements, advertisements or other commercial copy produced, provided or approved by sponsor for broadcast on a station approved by Lefra Productions (Ptv.) Ltd. or SPRINGS FRESH PRODUCE MARKET, MEAT WORLD or its affiliates, including proceedings or litigation alleging infringement, unlawful use or violations of copyright; and/or (f) any defect, alleged or real, in any product of sponsor's sold or provided as samples to third parties by Sponsor or by Lefra Productions (Pty.) Ltd. or SPRINGS FRESH PRODUCE MARKET or MEAT WORLD Centre as part of such party's responsibilities under this Agreement. The foregoing indemnities shall survive the termination of this Agreement.
- 38. Lefra Productions (Pty.) Ltd. or SPRINGS FRESH PRODUCE MARKET or MEAT WORLD or any officer, employee or staff member thereof assumes no responsibility for the safety of the property or vendor, his agents, or employees, from theft, damage by fire, accident, or any the cause.

The vendor assumes all responsibility for compliance with all pertinent ordinances, regulations and codes of duly authorised Local, provincial or national governing bodies concerning rules and regulations and the display rules and regulations issued by Lefra Productions (Pty.) Ltd. or SPRINGS FRESH PRODUCE MARKET or MEAT WORLD.
